# About the Website

When Out East Insurance Solutions updates the Terms, it will use reasonable endeavours to provide you with notice of updates to the Terms. Any changes to the Terms take immediate effect from the date of their publication. Before you continue, we recommend you keep a copy of the Terms for your records.

## Acceptance of the Terms

## **Registration to use the Services**

# WEBSITE PRIVACY POLICY

This Privacy Policy applies to all personal information collected by Out East Insurance Solutions via the website located at outeastinsurance.co.nz

# What is "personal information"?

The Privacy Act 2020 currently defines "personal information" as meaning information or an opinion about an identified individual or an individual who is reasonably identifiable:

whether the information or opinion is true or not; and

whether the information or opinion is recorded in a material form or not.

If the information does not disclose your identity or enable your identity to be ascertained, it will, in most cases, not be classified as "personal information" and will not be subject to this privacy policy.

## What information do we collect?

The kind of personal information that we collect from you will depend on how you use the website. The personal information which we collect and hold about you may include Name, Email Address, Postal Address, Contact Number, IP address.

## How we collect your personal information

We may collect personal information from you whenever you input such information into the website.

We also collect cookies from your computer which enable us to tell when you use the website and to help customise your website experience. As a general rule however, it is not possible to identify you personally from our use of cookies.

#### Purpose of collection

The purpose for which we collect personal information is to provide you with the best service experience possible on the website.

Your personal information will not be disclosed to recipients outside New Zealand unless you expressly request us to do so. If you request us to transfer your personal information to an overseas recipient, the overseas recipient will not be required to comply with the New Zealand Privacy Principles, and we will not be liable for any mishandling of your information in such circumstances.
